One nomination was received for **Assistant Chief of Department** and a motion was made by Hank McGee, seconded by JP Oldham to appoint 2nd Assistant Chief John Albrecht to the position of Assistant Chief of Department. Motion passed

The board decided not to fill the third chiefs position at this time.
