 - v. Replacement of lapel mics from the Koster Keunen fire in Watertown have now been received so all damaged equipment from that incident is now replaced.
 - vi. SCBA flow testing is completed on 9/10 with no failures found.
 - vii. There is a continual amount of broken SCBA masks. They are working on warranty coverage and why we are having this issue. They report that mask should not be stored connected to the regulators.
 - viii. 2 computers are outdated and can't be updated to windows 11. The Admin Asst. and Asst. Chiefs computers. A quote was provided, and a motion was made by Comm Olivero and seconded by Comm Scully to purchase the 2 items from the machinery and equipment line item. Motion passed.
